These grants do not need to be paid back and we benefited from this resource. Our school continues to provide a top-notch learning environment and is ready if something similar (God forbid) happens in our country again.

We also replaced the asphalt apron around the school which was crumbling into pieces. Cemetery Improvements and Perpetual Care Audit

As a matter of state law and diocesan policy, 25% of every grave sale is added to an investment fund that is kept in perpetuity. The gains from the investments are available for cemetery upkeep and improvements. When I arrived at the parish, it was unclear how much of the investment fund was principal and how much was gained in interest. The fund started in the late 1950's. We went back through records and recalculated the entire investment mix and came to a clear breakdown. Our cemeteries are financially sound. A breakdown of the findings is included on the cemetery report. As of 9/30/2021, the balance sheet was rectified to accurately reflect the lawfully calculated principal and interest for each cemetery. The year-end balance sheet in this report will still show a discrepancy, but next year it will be accurate. Thank you to those who tirelessly care for our cemeteries!

We are also adding a columbarium to our St. Mary Cemetery so that cremated remains may be interred with proper Catholic dignity rather than scattered or retained in the home. Our belief is that cremated remains are still treated like the body. They should be interred in the ground or in the columbarium in order to reflect our beliefs about the resurrection of the Body and provide a place for the family to visit and pray for the dead. Cremation itself is not contrary to Catholic teaching, but we must be careful with the remains.

Biblical-Based Tithing

As you can see, our average family gift went down this year slightly. It remains our goal to challenge each individual or household to give 5% of their income as gift in-faith. Another 5% is expected to be shared with other charities which may include the Bishop's Appeal. The minimum gift (formally known as church dues) has not been raised in over two years. So as of January 1, 2022, we ask at least \$650 per person, or \$1,300 per family per year.
