### MISSION STATEMENT

Strengthened by the Holy Mass and filled with devotion to the Blessed Mother, we are a parish of faithful Catholic disciples.

Our supportive family desires to bring people to the beauty of knowing, loving, and serving Jesus Christ our Lord!

#### Parish Data

During the 2023-2024 fiscal year, our parish witnessed:

- 472 Registered Families or Individuals
  - Parish membership is defined as attending Mass and placing at least \$1.00 in the collection every two years with your name on
- 364 Financially Contributing Units 100\$+ per annum
- Average Contribution per unit was \$854.42 for the 472 registered families or individuals
  - A key to future success is a 5% spiritual tithe per person/family, or at least a minimum gift of \$700 per person, or \$1,400 per family.
- Online Giving was \$111,223.71
- \$12,776.00 was given to diocesan collections for charities (i.e. Mission Cooperative Appeal, etc.)

- 5 Adults who were initiated into the Catholic Faith or got Confirmed
- 22 First Communions (Includes students trained at Holy Trinity)

### The Healing Power

Fr. Suess taught the children that *grace* is, "The gift of God that makes us holy." I was shocked one day when that definition rolled off the tongue of one of our high school CCD students. This past year, more people sought the healing grace of the Sacraments. Marriages were reconciled to the Christ and the Church. A group of young adults asked for Confirmation. We continue to host beautiful weddings. Some of our most cherished people received the Last Sacraments before death. We do not keep numbers on Confessions for good reason, but that area still needs work. Why wait? Anytime someone chooses a serious evil (i.e. mortal sin), Christ waits at the throne of mercy to heal them. People do not need to wait until Advent or Lent, and they do not need to carry their own burden. More grace is available!

#### What To Watch

The above financial summary includes only the main parish operations. The school runs at a significant deficit which is subsidized by the parish. 42% of the school's budget comes from the parish (up 4% over last year). 82 cents of each collection dollar goes to the school (up 12 cents over last year). What does this mean? It means that the school is the primary mission of our parish and it requires everyone's support. Those numbers will move in the right direction as we concurrently increase parish tithing to 5% of income for everyone who attends Mass, increase school and CCD enrollment, increase tuition at reasonable intervals, and control costs. We also rely on a number of spontaneous gifts and bequests. These shifts need to happen while also giving our teachers more competitive wages. Having a school means "all hands on deck". Thank you for *choosing* to make Catholic Education a priority!

As we work on the school ratios seen above, we still need to grow parish ministry as our core identity. We are holding funds in our budget to have a Pastoral Assistant (with a business focus) to assist Fr. Schuster. We are also holding funds for a part-time choir director, and increased adult education. It will take work to keep these items in our budget, but they are needed for our future.

Numbers never tell the whole story. "The love of Christ urges us on", said St. Paul (2 Cor 5:14). All of the number crunching is still about bringing people to Mass and the Sacraments, educating them in the Catholic faith, praying the rosary, and sending them to Jesus at the end of life. There are many signs of life and growth here at our parish. The true measures are not found in numbers, but in the personal growth each person experiences as they encounter Jesus Christ in prayer and the Sacraments. On that front, I, Fr. Schuster, believe that everything in this parish is moving in the proper direction towards Jesus.

### What's An Asset?

An asset is something of value that we hold or possess as an organization. It can be tangible, like a new pavilion. Or it can be intangible, like cash. Our net income does not look favorable. In light of that fact, we also have to consider that our assets have risen almost \$70,000 in the same time period (when you remove *one by One* money and do an apples-to-apples comparison). This means that a lot of what we spend financially is tied up in assets such as equipment and buildings. Even though our net income does not look favorable, you must know that we are at a safe operating level with our intangible assets (cash), and our value is actually rising because of the physical "stuff" that is now sitting on this campus. A liability is money that we need to have on hand for a specific purpose. In the same apples-to-apples comparison, our liabilities increased about \$46,000. Our assets grew by more than that, which is healthy. These distinctions are important in order to know if a negative net income is a sign of danger. Well... it is never a welcome sight. In this case, there is no danger. If we continue to perform in that manner, and we are not gaining assets along the way, then we would be on a crash course. We do need to try to get to a balanced budget for the sake of posterity and sanity.

### The Most Important Assets

The most important assets in this parish do not show up on paper. It is YOU! Your faith, your families, your time, your volunteering, your talents, your friendship, your tithing, your spontaneous gifts, the JOY Campaign, your positive conversations with others, your devotion to the Blessed Mother, your Mass attendance, vocations to the priesthood, your growing identity as a *disciple of Jesus Christ in the Catholic Church* - these are the most important assets in the parish among many others. Can you imagine what this parish and school would be like without its faithful volunteers? I cannot! God has you here for a reason, and I want to thank you for responding to the call to be an active disciple at St. Mary Parish! -Fr. Schuster
